Workshop Descriptions

- 1) Media Training for Presidents: How does the media work? What should you say when a journalist calls? Good media relations will help you get your local's message out in times of crisis and every day. Participants will learn new ways to deal with nervousness, and each person will be able to deliver their local's message, with confidence.
- **OMERS (French and English):** Participants in this workshop will be provided with an overview of their OMERS pension plan and how it works. The workshop will be conducted by representatives from OMERS.
- Action Committees: Many locals have started up Political Action Committees. What is the role of the PAC in mobilizing members, building alliances and planning effective actions to bring about change? Participants in this workshop will learn the tricks used by lobbyists to get their message across. Whether speaking with MPPs, MPs or School Trustees, activists will find this a valuable workshop.
- 4) Attack on Sick Leave Fighting Attendance Management Programs: Increasingly employers are implementing attendance management programs into the workplace. What are the limits to "management rights" in the running of such programs? What information does the employer have the right to know? What is the difference between legitimate medical monitoring and harassment?
- (i) Illness or WSIB Claim? Can an illness acquired at work be compensated through WSIB? What evidence would be necessary to establish a claim? What type of exposures need to be reported to WSIB? When is stress compensable?
 - (ii) The Unions Role in Early and Safe Return to Work Programs: This workshop will provide participants with an overview of the elements of a good Early and Safe Return to work program. What is the role of the Union? What is the role of the Employer?
- **Terms of Reference (Health and Safety)** (Blaine) This course is designed to provide understanding of the legislative requirements for the establishment of a Joint Health and Safety Committee. Learn about some of the challenges school board Health and Safety committees are having with their Terms of Reference.

- **Pay Equity Maintenance:** Once your local has implemented a job evaluation program, how are new jobs dealt with? How do you respond to reclassification requests? This workshop is ideal for new joint job evaluation committee
 - members who want to maintain the program in its original form. A basic knowledge of job evaluation would be required.
- **Social Media:** Whether it is to raise the profile of our work in the community or we are trying to organize a protest, social media can help. Learn the strengths and weaknesses of the tools available and how to use choose the most appropriate method to get the message out.
- 9) Union responsibilities under the Accessibility for Ontarians with Disabilities Act: The AODA was recently passed into law and includes directives for Unions. Is your Local meeting its obligations under the Act? This workshop will provide an overview of the legislation and provide concrete steps your local can take to become compliant.
- **Misconduct and Social Media:** Sure it's fun to see what everyone is doing, but will it cost you your employment?
- 11) Getting involved in Election campaigns: A provincial election could be called at any time. How do you encourage your members to take a more active role in election campaigns? What type of help is a candidate looking for? How do locals choose which candidate to support? How can you raise the profile of our issues in a campaign?
- 12) Understanding Board Financial Statements: Back by popular demand... Knowing how to read Board Financial statements is critical as we work to implement our new Collective Agreements. How do you determine the number of Full Time Equivalent (FTEs) you have? What does the Board do with the money they get from the government to fund our work?
- **13) Economic Literacy 101:** A workers' guide to basic economic terms and their meanings.
