Your Worship Mayor Finnegan and Prince Edward County Council:

The Prince Edward County is considering a proposal for a new wastewater treatment plant in Picton to be developed as a public-private partnership.

As part of your due diligence, we believe that it is important for Council to consider experiences and research which reveal that public-private partnerships (P3s) are neither good public policy nor good financial policy.

Our national union, the Canadian Union of Public Employees, has conducted extensive research into public service funding and operating models. Other public policy organizations such the Federation of Canadian Municipalities and the Canadian Council for Policy Alternatives have also published material related to these issues.

CUPE Local 2275 asked our National Research Department to gather material for Prince Edward County Council and to prepare a briefing for you that specifically addresses issues that must be considered in deciding whether or not to use a P3 model for a new sewage treatment plant in Picton. This binder contains material prepared by CUPE and other organizations about P3s, press clippings from other cities where P3 water and wastewater treatment projects have been turned down or gone wrong, and several reports from the City of Hamilton quantifying the decreased costs and increased quality in their water and wastewater treatment since bringing the system back in-house after 10 years with the P3 model. There is a Table of Contents at the beginning of the binder.

It is CUPE's conclusion that the P3 model is not the right model for Picton's new wastewater treatment plant.

As you are aware, Prince Edward County Council is and will be legally responsible for the quality of water and for wastewater treatment under the *Ontario Safe Drinking Water Act* and the *Ontario Water Resources Act*. The County will lose significant control over a sewage treatment plant owned or operated by a private corporation. It will be less transparent and accountable to the County than it would be under direct ownership and operation.

You will see from the material provided that P3s generally cost more than traditionally developed municipal infrastructure projects.

We urge you to examine these materials carefully and to make a decision that will be of the most benefit to the people of Picton
