Call the local President or Recording Secretary.

# Sample committee update summary

Since starting our advocacy group in September 2017, we have been meeting on the third Monday of every month at the office of CUPE2017. Our committee now has a bank account, managed through our CUPE District Council, allowing us to focus on the real issues of skill building and networking.

Our meetings have provided support and guidance to local advocates and through them we have imporved support for injured workers. We have been mentoring new advocates, as well as, continuing to inspire those with more experience.

We have brought in a guest speaker on the importance of Mental Health First Aid.

Most of our work has focused on navigating the complicated process of WSIB claims -- getting it right the first time, improving the chances of approval. At the end of each meeting we discuss either a claim file, appeal or any concerns members have brought to the table. Member confidentiality is always maintained.

The committee is working on a final draft of a pamphlet: "What do I do if I am injured", that is based on one created by another area committee.

Below is some of the feedback we have received about the work of the committee so far:

"Looking forward to another year... collective knowledge is the key to helping our members."

"Listening to all the different CUPE locals, I'm learning how other members approach and deal with cases and winning."

Moving forward our goals are to increase outreach to area locals and expand the groups membership. We are in the process of developing our communications strategy to make sure we are even more successful.

- Record, maintain and distribute minutes of all meetings
- Maintain up-to-date members list
- Manage and compose all correspondence
- To be elected in odd years for no more than two successive terms

### **MEMBERS**

- Member in good standing with their CUPE Local
- Injured worker advocates / representatives
- WSIB advisors or representatives
