We are hoping to have **Linda McQuaig** as our Keynote Speaker.

Journalist and best-selling author **Linda McQuaig** has developed a reputation for challenging the establishment.

As a reporter for *The Globe and Mail*, she won a *National Newspaper Award* in 1989 for writing a series of articles which sparked a public inquiry into the activities of Ontario political lobbyist Patti Starr, and eventually led to Starr's imprisonment. And as a Senior Writer for *Maclean's* magazine, McQuaig (and Ian Austen) wrote two cover stories probing the questionable business dealings of Conrad Black in connection with a US takeover bid in the early 1980s. An irate Black suggested on CBC radio that McQuaig should be horsewhipped. In 1991, she was awarded an *Atkinson Fellowship for Journalism in Public Policy* to study the social welfare systems in Europe and North America.

From 2002 to 2013, McQuaig wrote an op-ed column for the *Toronto Star*. Since April 2014, she has been writing a weekly column for *ipolitics.ca*.

She was the NDP candidate in the federal by-election in Toronto Centre in November 2013. She is author of nine books on politics and economics – including six national bestsellers – such as *Shooting the Hippo* (short-listed for the Governor General's Award for Non-Fiction), *The Cult of Impotence, All You Can Eat*, and *It's the Crude, Dude: War, Big Oil and the Fight for the Planet*. Her most recent book, co-authored with Neil Brooks, is *The Trouble with Billionaires: How the Super-Rich Hijacked the World (and How We Can Take It Back)*.

WORKSHOP DESCRIPTIONS

- OMECC Conference 2016 -

1.1 WSIB / DUTY TO ACCOMMODATE

This 3 hour workshop will facilitate detailed discussion regarding legislation that protects people with disabilities. The session will examine how the "duty to accommodate" arises and how it operates. The most current case law will be reviewed to give participants a clear understanding of the legal obligations of employers, workers and unions. In doing so, the workshop will review the following pieces of legislation as they apply to accommodation issues:

Canadian Charter of Rights and Freedoms, Canadian Human Rights Act, Ontario Human Rights Code, Occupational Health & Safety Act, Canada Labour Code, Workplace Safety and Insurance Act, and Accessibility for Ontarians with Disabilities Act.

2.1 HEALTH & SAFETY

What members need to know about Health and Safety in the workplace:

CUPE members need to work with Health and Safety Committee members and Health and Safety Activists to ensure that the workplace is healthy and safe for our members.

Learn about Health and Safety rights and how to support this important area of union work.

3.1 SOCIAL MEDIA

- What types of social media are available and how can they benefit my local?
- How are groups using social media for activism?
- How can I deal with people's resistance?
- What are the guidelines for using social media?

In this workshop you will explore questions like these and receive hands-on practice in a variety of social media formats: Facebook, Twitter, YouTube, Flickr....

4.1 TAKING ON PRIVATIZATION

This workshop examines the biggest threat to CUPE jobs and public services. Find out how to:

- Spot the early warning sign of privatization
- Respond to privatization and contracting-out threats
- Build a campaign to fight privatization in your local

5.1 BARGAINING SURVEYS
