RALLIES

Members took over Queen's Park several times recently for the Raise the Rates rally and to support 10 Days of Action for \$10 Child Care.

BARGAINING WINS

CUPE 2977, representing workers at Bethesda Community Services, won 7.56% over two years, 2x forced overtime pay and better benefits.

MEDIA COVERAGE

The placement crisis in Children's Aid Societies has continued to dominate the media. while the Raise the Rates campaign has helped drive the conversation around legislated poverty.

DEVELOPMENTAL SERVICES

We are organizing a **campaign** to raise awareness about the **privatization of passport services**. This shift threatens unionized jobs and compromises workers' rights and safety. When individuals or families choose private services staffed by non-unionized employees, it undermines the security of unionized positions, putting jobs at risk. Additionally, the privatization of these services can lead to health and safety concerns, as non-unionized workers often lack essential benefits like insurance and proper workplace protections. Our goal is to highlight these dangers and encourage support for unionized workers by promoting the value of secure, safe, and fair labor practices in public services like passport issuance. We'll have more updates and actions for members to take in the coming months.

CHILD CARE

Energy has continued to build in the child care sector, most recently with the launch of the Canada-wide campaign, Ten Days for \$10-a-Day Child Care and Decent Pay. The child care sector held a press conference and rally at Queen's Park on November 20th, together with our community allies at the Ontario Coalition for Better Child Care and the Association of Early Childhood Educators Ontario.

Meanwhile, CUPE has been busy organizing child care centres to ensure decent work, pay, and union protections for more workers, while bargaining units have continued to make incremental gains, most notably within composite local 2484's Raising the Floor coordinated campaign. This model was successful across multiple employers and is being undertaken for a second round. Finally, please share the new group Parents for Child Care with parents of young children in your life to help bring families who care about the future of child care together.

MUNICIPAL SOCIAL SERVICES

Never has the urgency to increase social assistance rates been greater with more people than ever forced to rely on food banks, living on the streets, and being legislated into poverty. In this context, the Raise the Rates coalition held a press conference and rally at Queen's Park on October 24, following rallies in Ottawa, Sudbury and Hamilton. We are now reaching out to various municipalities to connect with City and County Councils to out forth motions to petition the Ontario Government to Raise the Rates for OW and ODSP.

Beyond the campaign, your reps are also focused on stopping the centralized intake rollout which continues to

threaten the quality of services and safety of jobs across the province.
